2021 ANNUAL REPORT - PASTOR - KIMBY YOUNG

It is very hard to "measure" a year like this last one. It was not the disaster of 2020 with cancelled services and limited contact. But it was certainly not our normal year in the life of the church. How do we measure a year like this one just ended?

This thought reminds me of the song "Seasons of Love" from the Broadway musical "Rent." The song begins, "525,600 minutes, 525,000 moments so dear. 525,600 minutes - how do you measure, measure a year?" It's an excellent question. The singers go on to suggest that we could measure a year "In daylights, in sunsets, in midnights, in cups of coffee. In inches, in miles, in laughter, in strife." As the song deepens the lyrics suggest we could measure a year "In truths that she learned, or in times that he cried. In bridges he burned, or the way that she died." The final answer of the song is that, of course, we must measure a year or a life, not in minutes, but in love. We must measure love to see how far we have grown in God's grace. But then how do you measure love?

At church, how do we measure the year just passed. In 525,600 minutes. In over a hundred worship services, in over a thousand communion cups, in how many thousands or millions of prayers. In songs we have sung, in musical instruments played, in Bible study classes, in meetings we have met by zoom or in person, in potlucks or PYF brunches. More profoundly – in baptisms, in weddings, in funerals. In items donated to the food pantry. In renovation of a building for Joy Closet. In volunteer hours shared. In community built. In care created. In love – the love of God and love of other people. In love – truly. We measure in love.

On a personal note. I have colleagues in ministry across the country who are dropping like flies – quitting, burning out, giving up, losing faith. Churches are closing. It has been a hard year for so many people world wide. People have become fearful, angry, bitter and destructive. People are breaking. I have heard horror stories about churches and pastors falling apart.

But not here. Thank you. Thank you each and every one. For your support, your energy, your compassion, your contributions, your love. For checking on me and checking in on others. For offering yourselves and doing your part. For pitching in and understanding challenges. For offering new ideas and approaches. For being flexible with all the changes and demands (even if you aren't happy about it). Thank you all. Thank you for love.

How do we measure a year in the life of our church? 525,600 minutes. Measure in love. May we continue to be blessed, aware of God's presence as we follow Jesus Christ, serving others in the seasons of love ahead.

2021 ANNUAL REPORT OF SESSION

This past year presented some very difficult challenges for our session with all of the pandemic unknowns, various restrictions regarding the ability for our congregation to worship together in service and for session members to meet as a group. However, the Session met in 12 stated meetings and 3 specially called congregation meetings requiring action. Our meetings were conducted virtually with members calling in and using Zoom to host the electronic meeting. The Session is comprised of twelve members plus the pastor who serves as moderator. Ron Crabbs serves as Clerk of Session. The Session overall responsibility is for the spiritual welfare as well as the financial and programmatic operations of the Church. On January 11, 2021, the following were elected to serve in the following positions for 2021: Elder Mike McGuire was elected President of the Corporation, Elder Ron Crabbs elected as Clerk of Session and Secretary of the Corporation and Elder Wayne Rollf elected as Treasurer. The Session organizational structure is built using four pillars – Mission, Worship, Discipleship and Finance and Operations. Each pillar is led by 3 Elders and additional members of the congregation volunteer to serve on the various committees:

2021 FINANCE & OPERATIONS PILLAR ANNUAL REPORT

The Finance and Operations Pillar consists of Finance, Building and Grounds, Personnel, IT and Memorial. 2021 was a busy year for this pillar, especially as we were involved in many of the discussions leading up to the purchase of the new building for the Joy Closet.

The Finance committee meets monthly to review the Church Finances. This includes reviewing the check register, Balance Sheet and Income and Expense Statements for both the month and year to date along with preparation and periodic review of the annual budget. This pillar also reviews any other financial business brought to the Church throughout the year for approval prior to being presented to Session.

Please find below a brief summary of the Finances:

2020 Income: \$296,376.60 2020 Expenses: \$280,163.74 **Net Income:** \$16,212.86

Financial Highlights include:

- Completed application for the Payroll Protection Program (from 2020)
- Purchase of the new Joy Closet building (using only proceeds from the Joy Closet)
- Completed a full review of the bookkeeping funds managed in PowerChurch by Wayne Rollf
- Changed phone and internet service to Spectrum for faster internet at a cost savings
- Special fund established for the sanctuary sound and lighting systems. A down-payment was made to purchase equipment and secure an installation slot in 2022.
- Prepared the 2022 Budget

2021 DISCIPLESHIP PILLAR ANNUAL REPORT

We struggled again this year with discipleship ministries, unable to have in person gatherings. Several of our plans were cancelled by Covid surges and precautions. Families were stressed and overwhelmed. We took a step back to try to relieve pressure on families. Flexibility and adjustment were key this year.

The highlights of the past year for the Discipleship Committee were:

NURSERY - Allison Perry continued to provide childcare weekly in the nursery on Sunday mornings. Her consistent, kind presence and care is appreciated. She makes every child feel welcome and loved.

Sunday School

Sunday School for children and youth did not meet all year. In conversation with parents, the comfort level was not there for gathering in a small room without masks. Many families of small children are still not attending worship.

We reorganized the Sunday School age groupings based on current membership and potential. We will offer 3 classes - preschool-first grade, elementary and 7th-12th. The last quarter of the year we were searching for teachers to begin 2022. We have one lead teacher in each room. We are still looking for co-leaders in every classroom.

Adult Sunday School

Seekers and Servants class led by Paula Waters and Alice Rollf met weekly throughout the year with a consistent and faithful group of students. They started the year with "Wait and See." This fall they studied Jonah.

PYF - Presbyterian Youth Fellowship

PYF had a good year. See the report from Dave Rollf, Youth Director. Dave and Cindy's faithful leadership is appreciated, especially during these very difficult times.

Traveling Day Camp

TDC returned in June with an extremely successful camp. Thanks to the leadership of Kim and Karen Liu, Robin Tropansky and Marsha Cooper. Heartland Center made several changes because of Covid. One change was a reduction in numbers per group which lowered our numbers as a whole from 2019, the last time TDC was held in Gardner. We also changed from hot lunch to bring your own lunch because of Covid concerns. Children were outside as much as possible, even in an extremely hot week. Our leaders did a masterful job of adjusting and making it a fun experience for all.

New Member Classes

Though we have had some consistent visitors, we did not have a membership class in 2021. We hope next year will be an improvement.

The work of the Mission Pillar is to seek new missions and outreach opportunities locally, nationally, and internationally. For 2021 this included a mission of outreach to our members and community who were isolated while quarantined for protection against COVID-19 and the variants.

Souper Bowl of Caring Collection on Super Bowl Sunday – February

We joined millions of young people from across the nation in support of this fundraiser to end hunger. "Souper Bowl of Caring" works to mobilize those looking to fight hunger and poverty around the time of the Super Bowl football game. The congregation brought food items and/or financial contribution designated to "Souper Bowl of Caring." Donations went to the Johnson County Multi-Service Center of Gardner.

Valentine's Day Mission: February

Love God and Love People. We prepared over 40 boxes for church families who were not able to attend church. Following worship services, the congregation in attendance wrote notes of encouragement and love. The boxes were filled with valentine cards, homemade candys and cookies.

Love People in the community; We delivered 3 large platters of goodies to first responders at the Gardner police station, and two fire houses

Blessing bakers - February

A list of "Blessing Bakers" was gathered for special events and needs. This is a list of people we can call or email at a moment's notice to get an assortment of baked goods for a funeral, reception, or special event. The first event was the Valentine's Day baking.

JoCo Parade – August

Revive The Church Alive!! For the Johnson County Fair Parade, the First Presbyterian Church float was decorated with purple and white flowers, along with a 7-foot cross. The Praise Band sang beautifully as the float cruised the parade route. The singers, walkers, riders and watchers wore t-shirts that represented our many outreach programs: Joy Closet, Heartland Summer Camp, Youth Group and 1st Presbyterian church.

Meadowbrook Worship - November

During November our church was responsible for leading worship at Meadowbrook. The Worship was each Sunday starting at 3pm. As a safety precaution we took a small group of church members who were vaccinated musicians and readers of scriptures. They brought music, fellowship, and the word of God to the Meadowbrook residents.

Operation Christmas Child - Pack a Box: November

Cindy Rollf provided empty OCC boxes for the congregation to pack. There were bins filled with toys and other items to use from the Joy Closet. Approximately 40 Boxes were filled.

Joy offering: December

This denominational offering is received around Christmas Eve and provides critical financial support to retired Church workers (pastors, missionaries, musicians, and educators) and their families. Joy envelopes were provided to the congregation.

Children's Christmas Project: December

Gardner City Hall provided a list of children in Gardner in need of gifts for the holiday. The congregation adopted 10 children with 5 gifts per child. Gifts and gift cards were delivered to the First Baptist Church for distribution to the families.

Stephen Ministry:

Stephen Ministers are lay congregation members trained to provide one-to-one care to those experiencing a difficult time in life, such as grief, divorce, job loss, chronic or terminal illness, or relocation. We have three members trained for the Stephen Ministry. Kimby Young, Poppy Zurcher and Karen Elliott.

2021 was once again a challenging year for youth ministry. The pandemic continued through the year which limited attendance and opportunities. We were able to meet in person most of the year, but restrictions reduced energy, focus, and excitement. For the first time in memory, we were not able to hold our annual winter retreat at Heartland Center. This is a springboard event that helps motivate the group through the spring. The absence of the event was felt, but we overcame. We were also unable to host fundraising events with the congregation which have always served as fellowship opportunities for everyone. Again, we felt the effect of change, but pressed on. The congregation and community continued to support the ministry and mission of the group even without the tangibles. These tough years are a blessing and curse. While we miss what <u>we could</u> be doing, it has served as a lesson as to what <u>God is</u> doing.

This summer we were blessed with the opportunity to travel on our summer mission trip. Our team was small, but God's purpose in it was served. Four youth and two adults traveled to Copperhill, Tennessee with TEAMeffort for a week in July. We were partnered with a group from Knoxville, Tennessee and another from Columbia, South Carolina for our service project which was located just south of the state line in Blue Ridge, Georgia. We made great friends as we worked together to improve the living conditions for a resident, known only to us as Sandra. We went hiking, rafting, horseback riding, and played paintball. We enjoyed every minute of our time in fellowship over nine days, six states, and almost 2000 miles.

For the first time in many years the PYF did not graduate any seniors. This created a leadership void as there were also no active juniors. With no upperclassmen, the younger kids had to step up. They had to work a little harder to make the group their own and to redefine what it will be. At least half of our active youth are not from our congregation. This shows that our kids are good at inviting friends and that we have something to offer. Unfortunately, it also shows that our congregation must work on reaching families with children and youth.

As 2021 comes to an end, we must look forward. We look forward to opportunities that we refuse to pass up. We look forward to adventures that lie ahead. Most of all we look forward to how God will work through this group. How we will He use us to minister to those we call family? How will He use us reach out to those who don't yet know this family of faith and bring them in? How will He use us to serve His people within the walls of the church and those that may never step inside? Our group is anxious for God to answer these questions in 2022 and beyond.

The PYF would like to thank the congregation for their continued, very generous support. We are so excited to back to hosting our church-wide events. Having a great turnout this fall for what was our first brunch since the pandemic was inspirational on many levels. I truly believe that God means for us to be together. We ask for your prayers and encouragement as we embark on another year of youth ministry.

2021 JOY CLOSET ANNUAL REPORT

JOY Closet is a non-profit sponsored by First Presbyterian Church of Gardner which provides clothing, bedding, and shoes for individuals and families in need. The thrift store is open to the public and is served by donations from the community, sales to the public at thrift store prices, and by the service of volunteers from our congregation and individuals and church groups from across the community.

Voucher Report: In 2021, JOY Closet was able to help 658 families in need with merchandise valued at \$22,988. This statistic represents the heart of what JOY Closet does. JOY Closet vouchers are available through local churches, area law enforcement agencies, social service agencies, and all of the schools in the following districts: Gardner-Edgerton, Wellsville, and Baldwin. This system allows those families to shop at their convenience during store hours.

In addition to the above amount, we also provide items in emergency situations for families, some who have experienced a fire, a relocation from domestic abuse, and parents who receive foster children who simply arrive with the clothing that they are wearing. Our clothing also goes to Olathe Medical Center for use in their Emergency Room for patients in need and area nursing homes sometimes make specific requests.

Grand Opening and 8th Anniversary

JOY Closet has experienced a milestone year for our organization. Thanks to the congregation of First Presbyterian Church for their sponsorship and approval and with the assistance and approval of Heartland Presbytery, we were able to acquire the property at 975 E Lincoln Lane and renovate it to meet our needs. It has both a large sorting area where we could store out-of-season items and a shopping floor that serves the needs of our growing operation. We were able to celebrate a Grand Opening on October 19, 2021, with a ribbon cutting and special celebration incentives all week. Area businesses participated with free snack items and television news coverage was provided.

Expanded Store Hours We have been able to expand the number of volunteers through the growing interest of the community in seeing the work we have accomplished. With more volunteers, we have been able to expand our hours that we are open. Our present shopping hours are: Monday 10-7, Tuesday 10-7, Wednesday 10-4, Thursday 10-7, and Saturday 10-2. Volunteers are present during those hours and are quite often in the back working when the shopping floor is closed.

The work of JOY Closet represents our church well and reaches out into our community in ways that are greater than what any one person could accomplish. Thank you to our congregation for your continued support and prayer.

*the IRS mileage rate for 2022is 58.5 cents per mile.

Note: The pastor's compensation does not include the "employer's matching contribution" social security benefit of 7.65%. Clergy are classified as "self-employed" (not employees) and are responsible for paying the entire social security tax (normally 15.3%). These IRS rules apply only to ordained clergy; all other church staff are classified as employees and receive the regular employer matching contribution social security benefit of 7.65% of 1st numbers and are responsible for paying the other half (normally 7.65%) through payroll (FICA) tax withholding.

For the compensation package outlined above, the social security tax the pastor would be required to pay would usually be \$8,987.65. Regular employees earning a similar salary would pay half of this amount (\$4,493.82) and the other half would be paid by the employer on their behalf. Many employees do not realize that their employers are making these payments on their behalf. Pastors are also subject to state and federal income taxes, local property taxes, personal property taxes, sales tax, etc.
